

# 2021 NEWSLETTER CONTEST RULES AND REGULATIONS

## CONTEST

1.1 The “2021 Manitoba Teacher Magazine Newsletter Sign Up” (the “Contest”) provides residents of Manitoba, Canada who have attained the age of majority in their jurisdiction with a chance to win one of three (3) \$100 giftcards to anywhere they choose (the “Prize”).

1.2 \*Restrictions apply. Winner will be contacted by email. If the winner does not respond within one week of receiving the correspondence, a new winner will be chosen.

## CONTEST DETAILS

2.1 The Contest begins at 9:00:00 a.m. Central Time (CT) on June 1, 2021 and closes at 9:00:00 a.m. CT on September 1, 2021 (the “Contest Period”).

2.2 Contestants may enter the Contest one time only by submitting a valid email address on select Agriculture in the Classroom - Manitoba Manitoba Teachers Magazine Contest email newsletter sign-up pages. Only emails collected through this page during the Contest Period are eligible to win.

2.3 The Contest winner will be selected by random draw from all eligible entries.

## ELIGIBILITY

3.1 The Contest is sponsored by Agriculture in the Classroom - Manitoba and its partners and is open to residents of Manitoba (the “province”), who have attained the age of majority and reside in the Province, with the exception of the employees (current and past), agents and representatives of Agriculture in the Classroom - Manitoba and any of the Contest Partners’ subsidiaries, advertising and promotion agencies, suppliers of goods, prizes and services related to the Contest, any other persons directly related to the holding and or/sponsorship of this Contest, as well as their immediate family (father, mother, brothers, sisters, children), their legal or common-law spouse and any individuals with whom they reside.

3.2 The Contest Sponsor, in its complete discretion, may disqualify any individual from participation in the Contest (a “Participant”) and/or may refuse to award a prize under the Contest to any Participant where he/she has registered or attempted to register for the Contest by: a) Providing false and/or misleading information; and/or) Any means which would prejudice other Participants in the Contest, whether contrary to the Contest Rules and Regulations or through fraudulent and/ or illegal means;

## ODDS OF WINNING

5.1 The odds of winning Prizes will depend upon and will vary according to the total number of eligible entries received during the Contest Period.

## DRAWS AND PRIZES

6.1 The Contest winner will be selected by random draw from all eligible entries at the end of the Contest Period.

6.2 To be eligible and to be declared a winner by the Contest judge, a potential winner must meet all contest rules and the conditions of delivery of the Prize.

6.3 Only selected entrants will be notified by Agriculture in the Classroom - Manitoba.

## DELIVERY OF PRIZE

7.1 The sponsors of the Prize for which the entrant has been selected must be able to reach the selected entrant by email within one hundred sixty-eight (168) hours (7 days) of the draw.

7.2 If a selected entrant cannot be contacted or is contacted but does not claim his/her prize on or before that date, or does not meet all of the Contest rules and terms, the Contest judge(s) may disqualify the entrant from the Contest and another entry will be selected from all remaining eligible entries.

8.4 All Prize entries are subject to verification by the Contest Sponsor. Any such entry that is illegible, incomplete, and fraudulent, mutilated, reproduced by hand or mechanically, sent or submitted late shall automatically be disqualified and will not entitle the Participant to the Prize.

8.5 Decisions by the Contest Sponsor with respect to the Contest are final and binding on all matters of fact, interpretation, eligibility and procedure.

8.6 By entering this contest, the winners of the Prizes authorize the Contest Sponsor and its agents to publish and/or broadcast his/her name, likeness, photograph, place of residence, voice and/or any statement made in connection with winning the Prizes, without compensation of any kind other than the Prize awarded.

8.8 The Contest Sponsor reserves the right to modify the Rules and Regulations of the Contest without materially affecting the terms and conditions thereof.

8.9 The Contest is subject to all applicable federal, provincial and municipal laws and regulations

8.10 These Rules and Regulations govern the Contest and must be followed. In the event of any discrepancy between these Rules and Regulations and any other material, these Rules and Regulations prevail to the extent of the inconsistency.

8.11 The value of the Prizes is not dependent upon the number of Contest entries received.

8.12 The Contest and the Contest rules are exclusively governed by and construed in accordance with the laws of the province of Manitoba and any dispute shall be adjudicated in the courts sitting in Winnipeg, Manitoba.

Agriculture in the Classroom - Manitoba collects the personal information on the entry for its marketing activities.
